## Pond dam sinkhole, C Cove erosion get board attention

The Lake Board is seeking help from construction and engineering firms to deal with new developments at two existing problem sites, the Miller's pond dam and the C Cove shoreline at Woods Chapel Road.

### Sinkhole reveals void in Miller's pond dam

Board Member Mike Stiles reported July 1 that there was a sinkhole in the pavement of Anchor Drive where it runs over the Miller's pond dam above AB Cove. Stiles said it was 2 feet in diameter and 8 to 10 inches deep.

President Darren Davis reported at the Board's July 15 meeting that the Maintenance crew patched a 2.5-foot-square sinkhole. In the process, he said, they discovered a void beneath it that needed to be examined by professionals. The problem was found near the eastern end of the dam.

Board Member Clayton Holland suggested pumping flowable fill, normally a mixture of cement, water, fine aggregate, fly ash or slag, into the void to stabilize the situation as a temporary solution.

Davis said since flowable fill appears to be a solution, a bid was obtained from ICON Grading & Construction Inc. He said the board would attempt to get at least one more bid before the Aug. 5 board meeting.

Talks again stalled earlier this year between the board and heirs to the Miller farm about allowing Country Club access to the pond for rehabilitation of the dam and possibly the pond. Engineering consultant Affinis Corp. had advised it is possible to fix the dam from the Country Club's side of the property line -- a few feet into the pond -- but they do not advise it and urge another solution.

Affinis performed a 2020 concept design that called for remedial steps to manage stormwater and debris inflow and to correct deficiencies in outlet pipes and a failing limestone retaining wall on the dam face. The updated 2023 cost estimate was \$795,000.

## Lake voters to winnow 15 governor candidates on three ballots

Lake voters with the choices of three political party ballots get to choose Aug. 6 from among 15 candidates for governor, 9 for lieutenant governor, 6 for U.S. Senate, 12 for secretary of state, 8 for state treasurer and 4 for attorney general. Voters choosing the unaffiliated ballot get to decide only whether to approve two proposed state constitutional amendments.

Polls for the Aug. 6 primary election are open from 6 a.m. to 7 p.m. at the Clubhouse. Upon entering the polling place, registered voters have a choice of Republican, Democratic, Libertarian and unaffiliated ballots.

At the federal level, Sen. Josh Hawley, R-Mo., is unopposed on the Republican ballot for his party's nomination for the Nov.

5 general election. Four Democrats seek that party's nomination: Karla May, December L. Harmon, Lucas Kunce and Mita Biswas. W.C. Young is the sole Libertarian candidate.

Rep. Emanuel Cleaver II, D-Mo., is unopposed for renomination on the Democratic ballot in the U.S. 5th Congressional District. Sean E. Smith is running on the Republican ballot, while William Truman "Bill" Wayne is on the Libertarian ballot.

Nine Republicans are running for the nomination to succeed retiring Gov. Mike Parson: Darrell Leon McClanahan III, Jeremy Gundel, Bill Eigel, Robert James Olson, John R. "Jay" Ashcroft, Mike Kehoe, Chris Wright, Darren L. Grant and Amber Thomsen. Democrats running are Eric Morrison,

# July 4 Woods Chapel flood discharge displaces riprap

President Davis also reported July 15 that heavy rain and flooding early July 4 caused inflow from the Woods Chapel Road box bridge to displace riprap on the south shore of upper C Cove. He noted since the lengthening of the culverts under the bridge by Blue Springs' Woods Chapel Road improvement project in 2015, the culverts point directly at the south shore and, when full of water, direct its force onto the shore, overtopping the riprap.

Davis said he asked Affinis and engineering consultant OWN Inc. to propose solutions to the Woods Chapel bridge discharge problem. Davis said he also met the week of July 21 with Blue Springs city officials to begin conversation about direction of the bridge culverts, final project engineering plans, and how to cooperate to keep sediment, organic debris and garbage from entering Lake Tapawingo from the bridge culverts. The creek running under the road actually runs through unincorporated Jackson County after originating in Blue Springs.

Davis said the board hopes to find a solution to the problem, possibly changing the direction of the flow by a diversion on the lake side of the bridge or by reinforcing the shoreline.

The shoreline erosion problem was recognized as early as November 2015, about the time of completion of the Woods Chapel Road improvement project. It was reported at that time that TranSystems, the project engineer, offered to give the Country Club a drawing for raising the wing wall to reduce erosion on the south side of the weir, but Lake Tapawingo would have to pay for the work. In 2016, Blue Springs Public Works Director Chris Sandie said the erosion problem was occurring before the box bridge culvert was extended.

In 2017, a Lake Board committee said the engineers provided blueprints for reinforced seawall work to resolve the problem and it was attempting to get Blue Springs to pay for the work. Subsequent erosion made those plans impossible to carry out. The board conducted nearly monthly talks with lawyers, engineers and Blue Springs with talk of litigation against that city.

With no progress on that front, in June 2020, Lake Board discussion turned to new recommendations to mitigate shoreline erosion. In September 2020, the board hired silt pond constructor Hill Brothers to line the south shore with riprap for a bid of \$38,201.

## C Cove residents fight incoming debris, filth

Paul and Brenda Bowers, 23 Clipper, told the board they had removed inflow debris from C Cove following a recent storm and placed it all on a shelf by the spillway. However, the most recent storm washed all that debris back into the lake before it could be collected. Mr. Bowers asked whether the board could install a slab or some other structure to make it easier to remove the debris from the lake and from the structure later.

Davis and Board Members Wes Knox and Scott Patton offered ideas such as poles to capture debris or buoys with rope, expanding on ideas Davis previously presented to the board in 2023. Board Member Susan Stiles suggested the board engage an engineering firm to provide options that won't negatively impact water flow and form a committee to investigate possible solutions to bring before the board.

Mike Stiles said upper C Cove residents are cleaning up debris that runs into the cove but the water is now extremely

shallow from siltation since the last dredging in 2018 and the board should consider dredging that area. Knox, who used to live directly in front of the area in question, stated it will quickly fill with silt again after a couple of heavy rains.

**Fourth of July:** President Davis said the Fourth of July fireworks display went well. Board Member Kim McReynolds reported problems with people trying to get onto or to cross the dam when the road was closed to set up the fireworks display. Specifically, she said teenagers were taunting the fireworks contractor during setup. She said a board representative should be on the dam or security should be hired for that purpose.

Board Member Clayton Holland also reported issues of pedestrians wanting to cross the dam despite warning signs. Board Member Sarah Jordan said the board should ask the city to partner in enforcement of the road closure, saying the Country Club and city could be fined by the state and the event canceled for allowing such violations.

Board Member Wes Knox reported no significant boating issues over the holiday. Board Member John Nicol noted the Water Patrol was late to lead the 2 p.m. startup of the Boat Parade at Liberty Landing.

President Davis noted there were complaints of large fireworks debris, from amateur shooters, falling on houses and yards, especially in D Block. Jordan said some of those fireworks could be coming from the Blue Springs neighborhood, across

# Thanks to board; infrastructure action expected

I want to start off by thanking the 2024 Board of Directors for all of their hard work and taking the time to answer all of my questions. It's amazing how they find time during their busy lives to attend board meetings twice a month and work behind the scenes in many aspects of the Country Club.

Thank you to Mike Stiles for scheduling the repair on the dam and boat ramp and Brian Smith, Wes Knox and Clayton Holland for ensuring the work was completed.

A shout-out to Lake Tapawingo resident Steve Robinson who has spent the past month pulling weeds and cutting out the dead plants in Liberty Gardens. Thank you for all the hard work, Steve.

We are currently looking at two areas of our lake that need attention.

The road over Miller's pond dam above AB Cove has a trench below the asphalt where there are currently safety cones covering a rock road base. ICON Grading & Construction has inspected the work area and tentatively given an estimate for a flowable fill repair.

We will look at obtaining other bids prior to the board meeting on Aug. 5. The goal is to complete this temporary repair prior to the start of the school year.

During the last significant storm, a section of the C Cove shoreline riprap to the southwest of the Woods Chapel Road bridge and storm drain was washed away. We have contacted two engineering firms, Affinis Corp. and OWN Inc. The engineering firms can help assess how to best redirect the

incoming storm water towards the lake, instead of the shoreline.

The construction or placement of a system to collect incoming organic material and garbage could possibly work with the smaller storm water inflows. It might be difficult to predict how effective a collection system would be during larger episodes. Creating a path for maintenance of the cove has also been discussed.

## Fourth complaints: fireworks debris, booze vials in lake

the railroad tracks from D Block. She added the debris exhibited appeared to be from consumer grade, rather than commercial, fireworks. Hap Graff, 30 Dockside, described the debris as “little blocks of concrete” that fell on houses and yards, mainly between 11:30 p.m. and midnight. Board members acknowledged the problem but said residential fireworks discharges were governed by the city of Lake Tapawingo and possibly Blue Springs in this case and might require city ordinances.

Gina Graham, 34 Anchor, complained about Boat Parade competitors throwing plastic containers of beverage alcohol in the lake, referring to a Facebook post stating 1,000 tubes of alcohol were prepared for throwing to parade watchers. She cited Lake Rules that refer to federal and state regulations and provide a 6-point penalty for depositing garbage, refuse, yard waste or other foreign matter on the shore or in the lake. She added that the plastic containers are not biodegradable and add to litter in the lake and on the shoreline.

Nicol said the Sportsmen’s Club, which organizes the Boat Parade, could ask participants to stop the practice.

Board Member Brian Smith likened the alcohol-throwing to candy throwing during the St. Patrick’s Day Parade. Graham said the difference is the boat litter ends up in the lake.

Jordan asked Nicol how much revenue the Sportsmen’s Club received from fireworks sales. He said sales were less than the last few years but the club normally makes about \$10,000 that supports Lake scholarships and underwrites annual dinners and events, which the club sponsors at no profit.

**Dam and Spillway:** Board Member Clayton Holland said the lake level would be lowered 6 to 10 inches on July 15-16, with concrete repairs by Legacy Underground Construction to take place on the spillway on July 17. A no-wake order would be imposed on the lake July 16-18 to prevent spillage of water onto the new concrete until it cures. Meanwhile, concrete contractor Chad Eickleberry was to perform underwater concrete repairs to the boat ramp, sandbagging around the hole in the ramp in order to pour concrete. That work was to be completed July 17 with two days to cure before reopening the ramp.

**Boat Lots and Lease Lot:** Board Member Clayton Holland said he looked into a water runoff problem in the B Block Boat Lot and presented photos of erosion of the gravel drive by fast moving water. He moved that rock be placed in the road to prevent erosion. He said Maintenance Coordinator Matt Kempf estimated that about 20 tons of 1.5-inch rock is needed, costing between \$1,000-\$1,500. He said Kempf would grade the existing road and a delivery of rock would be placed and spread over that. The board approved, 13-0.

Holland subsequently reported the rock had not been ordered yet. He said it was decided to place the rock in the Maintenance building lot first, but equipment of city contractor Underground Plumbing Pros must be moved to make room.

Valerie Frankeberger, 58 Beach, said much gravel and mud had washed from the B Block lot across the road into her driveway. She said she heard there used to be a drain in that location to carry away runoff. Holland said placement of 20 tons of rock should disperse the water rather than let it channel off toward the road. He said Kempf had been delayed in

Crystal Quade, Sheryl Gladney, Hollis L. Laster and Mike Hamra. Bill Slantz is on the Libertarian ballot.

Six Republicans are running for the nomination to succeed governor candidate Mike Kehoe as lieutenant governor: Holly Rehder, Dave Wasinger, Lincoln Hough, Paul Berry III, Tim Baker and Matthew E. Porter. Democrats running are Richard Brown and Anastasia Syes. Ken Iverson is on the Libertarian ballot.

Eight Republicans seek the nomination to succeed governor candidate Ashcroft as secretary of state: Valentina Gomez, Shane Schoeller, Denny Hoskins, Adam J. Schwadron, Jamie Corley, Dean Plocher, Mary Elizabeth Coleman and Mike Carter. Democrats running are Monique Williams, Barbara Phifer and Haley Jacobson. Carl Herman Freese is on the Libertarian ballot.

State Treasurer Vivek Malek is challenged for the GOP nomination for treasurer by Cody Smith, Andrew Koenig, Lori Rook, Tina Goodrick and Karan Pujji. Mark Osmack is unopposed for the Democratic nomination as is John A. Hartwig Jr. for the Libertarian nomination.

Attorney General Andrew Bailey is challenged for the Republican nomination for attorney general by Will Scharf. Elad Jonathan Gross is unopposed for the Democratic nomination as is Ryan L. Munro on the Libertarian ballot.

Rep. Chris Sander, R-Lone Jack, is challenged for renomination on the Republican ballot in the 33rd Missouri state House district by Carolyn S. Caton of Blue Springs.

There is no Democrat or Libertarian seeking the seat.

John Gromowsky, Stephanie M. Burton and Melesa Johnson are competing on the Democratic ballot to succeed Jackson County Prosecutor Jean Peters Baker, who did not seek re-election. Tracy Chappell is unopposed for the nomination on the Republican ballot.

## Two state constitutional amendments offered

On the three party ballots and on the unaffiliated ballot are two constitutional amendment proposals.

Constitutional Amendment No. 1 asks whether places in which individuals, corporations, organizations and associations provide non-home child care should be exempt from property taxes. It is intended to make child care more available, supporting children, families, the work force and society as a whole.

Constitutional Amendment No. 4 asks whether Kansas City should be required to spend at least 25 percent of its general revenue on funding for the Kansas City Police Department, up from the current 20 percent requirement. Kansas City has the only police department in Missouri that is run by a commission appointed by the governor, which has been the case for more than 80 years.

Missouri has an "open" primary that does not require voters to affiliate with a particular political party when they register. In an open primary, voters may take a ballot for any party and vote for those candidates.

# Lake Board completes citation/appeals rules changes

dealing with the boat lot due to the need to deal quickly with the Miller's pond dam road sinkhole.

**Bylaws, Rules and Regulations:** Secretary Kim McReynolds read the third reading of the following proposed rule changes (Deletions are in stricken type while additions are in boldfaced italic):

1. ENFORCEMENT OF RULES AND REGULATIONS, C. PROCEDURE, ITEM 3: CITATION APPEAL (a): All citation appeals must be in writing to the Enforcement Committee and received by the Lake Tapawingo Country Club Office no later than ~~45 days~~ **ten (10) business days** after the citation is ~~issued~~ **delivered**.

2. ENFORCEMENT OF RULES AND REGULATIONS, C. PROCEDURE, ITEM 5: APPEAL OF SUSPENSION (a): Appeal of Suspension of Lake Privileges must be in writing and received by the Lake Tapawingo **Country Club** Office within ~~45 days~~ **ten (10) business days** after suspension is ~~issued~~ **delivered**. Lake privileges are revoked until the appeal is reviewed and a decision rendered by the Country Club Board of Directors.

The board passed, 13-0, a motion by McReynolds to give final approval to the amendments.

McReynolds noted a recent successful citation appeal resulting from an ambiguous definition of fishing methods. While Lake Rules prohibit throw lines, trotlines or setlines, jug fishing is not specifically prohibited. Additionally, she noted there had been a question about use of electric boats on the lake.

McReynolds suggested the board update fishing and boating regulations to provide guidance on additional fishing and boating options not available when the rules were originally drafted. Board Members Mike Stiles and Scott Patton offered to help the committee draft language to update the related rules and regulations.

**Treasurer's Report:** Treasurer Scott Johnson said this year's real estate sales transfers fees have generated \$14,000 from 14 sales. However, he said if the board had a transfer fee of 0.5 percent or 1 percent instead of a flat \$1,000 fee, the Country Club would have collected \$32,500 or \$65,000 based on reported sales values. Johnson recommended the board consider a percent-based fee as a source of revenue. Board Member Mike Stiles noted the \$1,000 fee was established based on an estimate of the cost of office time to facilitate property transfers.

Hap Graff, 30 Dockside, said it appeared about nine residents have not paid their annual assessments and that the board should begin a collections process to force payment. He added that the bill payment list should itemize the purchases employees make on Country Club credit cards because previous employees had at one time purchased personal items on the cards.

**Docks and Waterfront:** **62-A.** Mike Cherepak asked for approval to use dirt and rock fill, after quarantine, to remedy some sinking areas of Country Club lakefront immediately in front of his 62-A dock, which is being repaired. The board passed, 13-0, a motion by Board Member Scott Patton to approve.

**64-A.** Hap Graff, 30 Dockside, said his sister, Natalie Graff-Baker, 63 Anchor, has purchased 64 Anchor and asked how to remove a sailboat lift on the seawall in front of the house. Board

Member Brian Smith said the lift could be floated to the boat ramp on old dock foam and disassembled. John Braden, 45 Anchor, said the lift is a lightweight jet ski lift similar to his own that likely could simply be lifted onto the seawall and removed.

**80-A.** Dave Brumagin, 80 Anchor, said he submitted an application to the city for replacement of a concrete sidewalk beside his house that also would extend from his property line across the Country Club lakefront to the seawall. He said the sidewalk would follow the footprint of an existing sidewalk but would eliminate steps from that walk. Board Member Sarah Jordan said Brumagin should secure a certificate of insurance that lists the Country Club as an additional insured and a contract that states any damage to adjoining property would be repaired.

**178-A.** Board Member Brian Zoller presented an application from John Wymore, owner of 178 Anchor, to install a dock in a space approved by the board in April. The dock space is unconventionally shaped due to the irregular shoreline, though there is 47 feet, 7 inches between the neighboring 4-A and 5-A docks allowing at least the required 15 feet on each side of the new dock. The dock is to be 15 feet long and 12 feet wide sitting at an angle with access by a walkway around the cliff. The board approved, 9-0, a motion by Zoller that the application be approved.

**187-A.** Board Member Brian Zoller presented an application from Joe and Margie Lehmkuhl, 187 Anchor, to replace their 187-A dock with a dock 12 feet wide by 30 feet long due to the shallow water. The dock would be in the existing location between 68-A and 69-A. The board approved, 9-0, a motion by Zoller that the application be approved.

**207-A.** Larry McCue, 83 Anchor, requested an alteration to a previously approved seawall construction application at 207-A. Due to possible eventual work on the nearby Miller's pond dam, McCue asked to reduce the length of the new seawall to 100 feet from 120 feet. Board Member Brian Smith said a neighboring dock that would be detached during the seawall construction would have to be updated to use encapsulated foam because Lake rules state any existing dock being transferred to a new location must meet current standards for new docks. McCue agreed. The board passed, 13-0, a motion by Board Member Mike Stiles to approve the amended application.

**45-B/46-B.** Board Member Mike Stiles presented applications to replace interconnected seawalls of Chuck and Elizabeth Welch at 45-B and Theresa Kingsley at 46-B. Contractor Chad Eickleberry is to rebuild both as a single project measuring about 57 feet long. The

dock at 45-B would be reattached in its current position, however at a 5-degree angle, which would not affect neighboring docks or mooring, to allow for better access for 45-B. Eickleberry is to protect an existing drain pipe in the current seawall, remove all debris and utilize a silt fence during the project. The board passed, 13-0, separate motions by Mr. Stiles to approve each application.

**117-B.** Board Member Brian Zoller presented an application from Justin King to widen the ramp on the 117-B dock from 4 feet to 12 feet to match the width of the dock. He said the length of the ramp would remain the same at 9 feet on the 15-foot-long dock for the current total length of 24 feet. The board approved, 9-0, a motion by Zoller that the application be approved.

**17-C.** Tamara Thissen presented a request to update a previously approved, but expired, permit to modify the 17-C dock in upper C Cove. At the May 15, 2023, meeting, Thissen had asked to install encapsulated foam on her nonconforming 17-foot-wide by 10-foot-long dock and to turn it perpendicular to the seawall. At that

time, she was informed that heavy rains and resulting water velocity in the cove could endanger her dock if it extended 17 feet into the cove. She amended her permit, seeking a 25-foot-wide, 10-foot-long dock, which was rejected by the board, which then approved repairs to the 17-foot-wide by 10-foot-long dock with encapsulated foam.

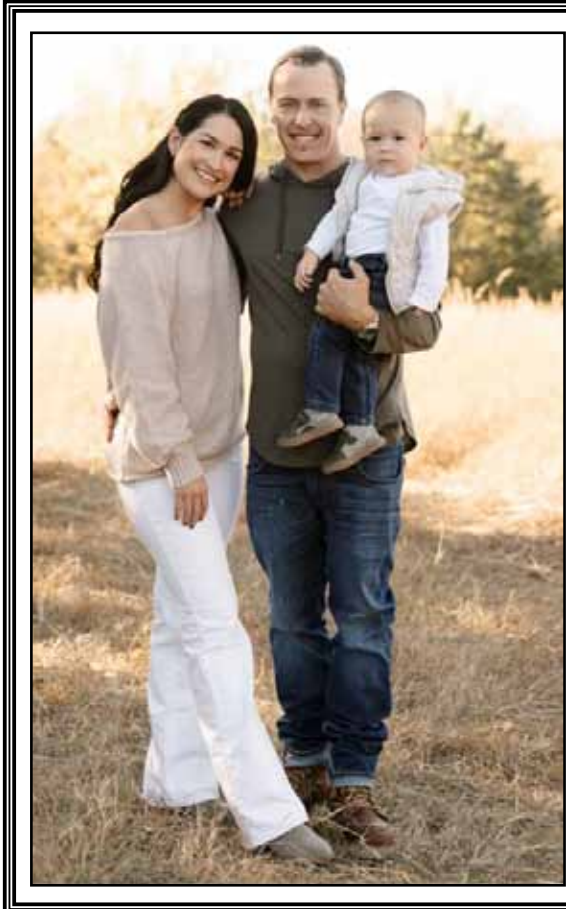
Thissen returned to the board, instead asking to extend her existing dock an additional 4 feet into the cove so it would have a final measurement of 17 feet wide by 14 feet long. Board Member Kim McReynolds noted although Lake Rules allow for docks that are 14 feet wide (with a well) and 25 feet long, the orientation parallel to the seawall prevents the approval. Board Member Mike Stiles reminded Thissen that her dock is grandfathered as nonconforming at 17 feet wide, the requested orientation and footprint are nonconforming and that the only updates that were permitted were maintenance for the existing footprint and to replace the nonencapsulated foam with encapsulated. Thissen withdrew her request.

**26-E.** Board Member Brian Zoller presented an application from Joe and

Monica Kroupa to replace a 14-foot-wide by 30-foot-long 26-E dock with a 12-foot-wide by 25-foot-long dock. Board Member Andy Gibler noted the dock is attached to a concrete platform that extends 7 feet from the seawall. Board Member Brian Smith said the board has been considering dock length to include the length of such a concrete platform as part of the total dock length, which would mean the proposed dock would total 32 feet long. Lake rules allow a maximum dock length of 25 feet, except in cases of shallow water when a dock may extend no more than 30 feet. Zoller was to return to the applicant to discuss possibly shortening the proposed dock.

**Roads, Easements & Pathways: D Block pathway.** Board Member Kim McReynolds asked if a pathway post could be placed on Country Club property between Liberty Gardens and 62-D so residents would have an alternative pathway to the one between 55- and 56-D. She said currently that pathway receives all pedestrian and golf cart traffic in that area.

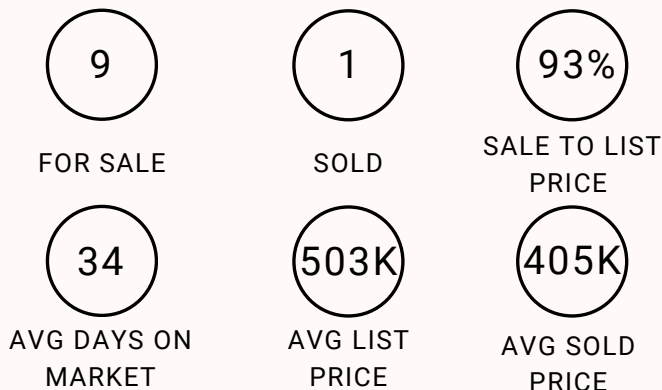

# Board deals with more damaged, ailing trees

Board Member Scott Patton suggested the board educate residents on proper golf cart etiquette and remind residents they should not use carts on wet or damp grass or park for more than one hour. McReynolds supported that idea, but said it does not solve the problem of having a single access point for a lot of golf cart traffic over 10 lots spanning six homes. It was noted some residents place furniture on Country Club property that impedes lakefront access.

Board Member Clayton Holland said there are extra pathway posts and he would look at the area with Maintenance.

**Tapawingo Lane business parking.** John Braden, 45 Anchor, asked about the new Camp Lucky dog training facility on Tapawingo Lane inside the U.S. 40 gate. The business has erected a six-foot fence with a gate around the property and parks cars on Country Club grass at the roadside. Board Member Kim McReynolds said the property is within unincorporated Jackson County and the fence and gate are permitted by the county. The Country Club is to discuss No Parking signs with the city to prevent continued parking by the business' customers on roadside Country Club property and speak to the business if they are observed to be using private, Country Club facilities for their dog training.

**Boat ramp parking violations.** Board Member Wes Knox said parking for the Water Patrol near the boat ramp appeared to be better than it has been recently.

**Maintenance: Buoys.** Board Member Brian Smith said three missing buoys are to be replaced. He also suggested replacing "can" buoys with red ball buoys that would be less expensive and more resistant to damage. Smith presented a sample of a 27-inch-diameter red ball buoy, which he proposed to gradually replace the current can buoys. The inflatable buoys cost \$216, compared to \$700 for a can buoy, he said. In addition, they would be marked with reflective tape rather than using expensive solar lights. Smith proposed using it to replace a missing buoy off 26-B and testing it, including whether the buoy and cable remain afloat if not inflated.

President Davis said an extra buoy had been placed in the entrance to Railroad Cove to meet concerns about the main buoy being moved up into the cove.

**Tree trimming, removal.** Board Member Brian Smith asked how much money remained in the tree maintenance budget. Treasurer Scott Johnson said although the board has approved thousands of dollars for tree maintenance recently, only \$5,000 has been paid from the \$30,000 budgeted. Smith then presented bids from Monster Tree Service, noting there might be added costs for moving docks temporarily during tree removal:

- 26-A. Two lakefront trees require pruning, but not total removal, for \$585 and \$234;
- 43-A. Trimming a tree that hangs over a residence for \$585;
- 52-D. Removal of a dead lakefront cottonwood tree that poses a risk to adjacent docks; Williams Lakefront will be hired to temporarily relocate docks during the removal by Monster Tree for \$9,360;

55-B. Tree fell on a residence during May wind storm; Monster previously inspected the tree and determined it did not pose a risk; Claims for reimbursement or damages to proceed through the normal insurance process; Monster to prune trees for \$468 and \$234; Maintenance Coordinator Matt Kempf and Monster to look at other trees in the area to see if maintenance might be required;

- 78-B. Total removal of a fallen lakefront tree for \$805;
- 118-D. Total removal of ant-infested tree in empty lot for \$819;
- 144-A. Tree by the Maintenance building near the tennis courts to be removed for \$702.

The board approved, 13-0, a motion by Board Member Mike Stiles to postpone action on the tree at 118-D since it does not pose a risk to property.

The board passed, 13-0, a motion by Smith to approve the remaining bids totaling \$12,973.

30-D. Smith told Hap Graff, 30 Dockside, that Monster Tree Service determined a lakefront tree at 30-D is healthy and the board would not remove it. Additionally, he said Graff could not pay to remove it as it would set a precedent for other residents who might want to remove Lake trees. Graff said the alternative was for the board to spend money periodically removing dead limbs.

**Parks and Beautification:** Board Member John Nicol noted the flower beds in Liberty Gardens require extensive weeding and maintenance. President Davis subsequently said he and Steve Robinson, 48 Dockside, had worked together to clean up an overgrown Liberty Gardens flower garden berm.

Noting Liberty Gardens and other Lake landscaping has become overgrown since Andy and Kristy Rogers quit their gardening job for the board, Davis said Robinson was interested in performing weeding and maintenance of Lake grounds. Robinson indicated he could work on areas that had been worked by the

A couple of City notes, we did request bids for the trash service. Our current contract with GFL was ending. Only two companies submitted bids, GFL and Earth First. GFL was significantly lower and Earth First had only limited experience with municipalities. I would assume that GFL will be awarded the contract once again as going with Earth First would necessitate a significant increase in the trash service billing.

On a second City note, our Planning & Zoning Commission met July 23 to discuss various issues. As first business, they elected Gary Mallen chairman, succeeding Andy Rogers who moved from the Lake. Nicol named to Council vacancy

The Board of Aldermen of the city of Lake Tapawingo met July 11 at City Hall. Mayor Tom Rodenberg presided.

**Visitors:** Gina Graham, 34 Anchor; John Nicol, 59 Dockside; Charles Plank, 38 Dockside; John Braden, 45 Anchor; Brad Hegwer, Earth First Waste Solutions.

**Council vacancy:** Mayor Rodenberg introduced John Nicol, 59 Dockside, as his nominee to fill a Ward 3 vacancy on the City Council due to the resignation of Alderman Morgan Combs, who moved from Ward 3 (D and E blocks) to Ward 1 (A Block). The council passed, 4-0, a motion by Alderman Steve Magel to approve Nicol's appointment to the vacancy. City Clerk Paul Blixrud then inaugurated Nicol.

**Police:** Chief Tammy Taylor introduced Kenneth Brooks, the city's newest part-time police officer. Brooks has served with the Kansas City, Mo., Police Department and the University of Missouri-Kansas City police.

Taylor said new handheld and car radios were installed and working. She said she was awaiting one last step for encryption.

Rogerses, including Liberty Gardens, the gates, the triangle by the Lake Office, around the Lake Office and City Hall, along Tapawingo Lane and the former Station lot at the U.S. 40 gate.

The board passed, 9-0, a motion by Board Member Sarah Jordan to pay Robinson \$500 per month for the work through the end of October.

**Water Patrol pontoon boat sale:**

President Davis said a listing would be posted offering the Lake's extra pontoon boat for sale. Board Member Brian Smith said Monster Tree Service was interested in the boat, without the motor, for \$500. The board listed the boat for sale, as is, for \$2,000. Davis subsequently said the best offer received so far was \$1,500.

**Liberty Landing dock:** Board Member Mike Stiles noted the board never budgeted repair or replacement of the Liberty Landing dock, which Board Member Brian Smith said was estimated to cost \$40,000 to \$50,000 due to the rotting framework. Mr. Stiles proposed the board develop a new dock with parking or mooring for six to eight pontoon boats and four to six runabout/fishing boats creating a small, commercial marina leasing space to residents who might not be able to afford a dock or whose dock space is not ideal. Board members questioned how the boats could be secured from vandals or thieves coming into the Lake from Woods Chapel Road.

**Quarantine:** Board Member Mike Stiles asked when the board would revisit quarantine procedures and possibly introduce more flexible options. Board

Member Scott Patton proposed a heated power wash for boats as a way to avoid quarantine. Mr. Stiles added that the board could offer that service, for a fee, ensuring that it is done with heat and properly. Board Member Clayton Holland noted that the quarantine procedures, while not perfect, work and have kept the lake safe for a number of years.

**Lake Management: Boating training.**

Hap Graff, 30 Dockside, suggested the board set up a boating training program for new residents.

**Executive session:** The Board adjourned the July 15 open meeting and reconvened in closed executive session at 8:49 p.m.

# Marina & Boating Safety

Boats can be a great source of summer fun and leisure. But, boaters, swimmers, and marina staff must be aware of dangers in and around the water. Electrical hazards and carbon monoxide (CO) bring unique risks to the boating world. Learn to protect people and pets from these dangers.

## ELECTRICAL SAFETY

- »» Never allow swimming near the boat, marina, or launching ramp. Residual current could flow into the water from the boat or the marina's wiring. This can put anyone at risk of electrical shock drownings (ESD).
- »» Be sure your boat is well maintained. Have it inspected each year. Ask a qualified marine electrician to do this job.
- »» Ground fault circuit interrupters (GFCIs) and equipment leakage circuit interrupters (ELCIs) should be installed and tested monthly. Run tests to find out if electrical current is leaking from the boat.
- »» Only use cords intended for marine use. Never use household cords near water.
- »» Know where your main breakers are on both the boat and the shore power source. This will help you respond quickly in an emergency.

## CARBON MONOXIDE SAFETY

- »» Poorly tuned engines produce more CO. Keep your engine properly maintained. Follow manufacturer's instructions for service.
- »» Proper ventilation for engine and generator exhaust vents must be clear and pipes should be inspected for leaks.
- »» Get into fresh air right away and get help if you feel symptoms of CO poisoning. These include headache, fatigue, confusion, dizziness, nausea, or seizures. The symptoms can be similar to seasickness. Assume it is CO exposure until you are sure the boat is safe.
- »» Do not swim near the boat's exhaust vents. CO accumulates there.
- »» Install CO alarms inside your boat. Test CO alarms before each trip.
- »» Choose a CO alarm that is listed by a qualified testing laboratory.
- »» If the CO alarm sounds, move to a fresh air location right away.



## KNOW THE RISKS!

Electrical shock drownings can occur when marina electrical systems leak electrical current into the water. Boats can also serve as the source of an electrical leakage. Leakage can cause a shock that can injure, disable, or kill a person.

Carbon Monoxide is a gas you cannot see, taste, or smell. It is often called the "invisible killer." CO is created when fuels such as gasoline, diesel, or propane do not burn fully. CO is also produced when wood or charcoal is burned.

Sources of CO on your boat may include engines, gas generators, and cooking ranges. Space and water heaters can also be sources of CO. CO can collect anywhere in or around a boat. The gas is harmful to both people and to pets.

## FACT

**CO can remain in or around your boat at unsafe levels even if the engine has been turned off.**

# Zebra mussels discovered in Longview Lake

The Missouri Department of Conservation reported July 26 that zebra mussels have been found in Longview Lake in southern Kansas City. The department said the newest discovery of the invasive species in Missouri was by Conservation Department staff.

Zebra mussels were found in 2017 in Jackson County's interconnected Prairie Lee Lake, Lake Jacomo and Blue Springs Lake. They are also in nearby Lake Lotawana and other lakes including the Lake of the Ozarks, Bull Shoals Lake, Carrollton Recreation Lake, Lake Taneycomo and Smithville Lake. They also have been found in the Missouri, Osage and Meramec rivers and in streams downstream from infected lakes.

Though Prairie Lee, Lake Jacomo and Blue Springs Lake are near Lake Tapawingo, they are on a different branch of the Little Blue River drainage basin. Water from the three county lakes drains into the Little Blue River, away from Lake Tapawingo, and into the Missouri River west of Sibley. Longview Lake is on the mainstem of the Little Blue River, draining directly into the Missouri.

Zebra mussels are spread by human activity, transporting infected boats, docks, lifts and assorted gear to previously "clean" bodies of water. Originating in Central Asia, zebra mussels were transported to the Great Lakes in ocean tanker ballast water in the 1980s only to spread from there by hitching rides on humans' boats, trailers and other gear.

The prolific mussels can harm boats and docks, encrust all lake surfaces, and destroy the aquatic ecology that supports sport fishing, boating and swimming. They are filter feeders that filter large quantities of water, removing the microscopic plants and animals that most young fish need as their first foods.

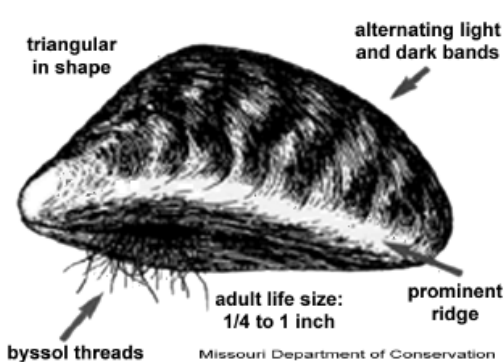


Zebra mussels encrust a boat outdrive.

No effective way has been found to exterminate them.

Each female zebra mussel can produce as many as a million eggs per year. These develop into microscopic free-

swimming larvae called veligers that can float into new waters, such as downstream lakes, or be transported by unwary boaters and fishermen. Veligers quickly begin to form shells and



attach to any firm surface.

Unlike common mussels, the dime-sized zebra mussels use adhesive filaments called byssal threads to attach to any firm surface. They clump together as they grow and cover rock, metal, rubber, wood, docks, boat hulls, native mussels, crayfish, and even aquatic plants.

Zebra mussels disrupt the aquatic food chain, starving out fish. They are known to clog even large utility water intake pipes. Their sharp shells make it hazardous to walk barefoot on shorelines and encrust docks, ladders and boats.

Lake Rules prohibit the transfer of boats and gear between Lake Tapawingo and other water bodies unless quarantined before they return to Lake Tapawingo. Violation of invasive species rules -- including using the lake without prior invasive species training -- can result in revocation of Lake privileges for up to a year, fines by the Missouri Department of Conservation or other agencies, or civil damages awarded to the Lake Tapawingo Country Club.

The Lake Board offers -- and requires -- in-person invasive species training in the Lake Office on the third Saturday of every month. Training is required before residents may obtain boat registration stickers or dock permits, or use the lake "for any activity." Rules require a member of each household to be retrained every two years.

## City Council to choose from solid waste bids in August

**Solid waste service:** City Clerk Paul Blixrud opened the two bid packets received for three years of refuse service that is to begin Sept. 1. Blixrud said he had sent out about eight bid packets to prospective bidders. The first packet opened was from the city's current provider: GFL Environmental. The cost per house per month was the same as the current price, which is \$17.50 per house per month. The second packet came from Earth First Waste Solutions and their cost was \$22.40 per house per month if yard waste is only picked

up seasonally (April through late November); or \$22.70 if yard waste is picked up weekly all year round.

Brad Hegwer of Earth First Waste Solutions introduced himself and gave a quick background of himself and his company. Chief Tammy Taylor said she was concerned whether trash trucks could work around the school bus schedule during the school year. Hegwer said that could be accommodated.

Mayor Rodenberg, Blixrud and one or two aldermen were to review the bids for consideration of an award at the Aug. 1 council meeting.

**Community Development:** Alderman Steve Magel said there was a Planning and Zoning Commission meeting scheduled July 23 at City Hall. He said he had several items to discuss in this work session and invited any of the City Council members to attend. Mayor Rodenberg said he planned to attend.

Mayor Rodenberg thanked Rob Markey, 1 Beach, for agreeing to serve on the Board of Equalization.

# Musical favorites made sweet sounds for Boat Parade

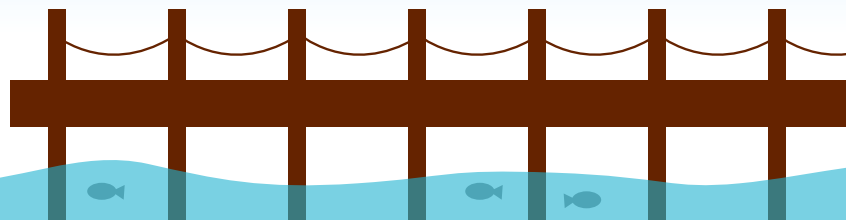

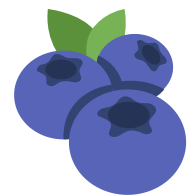
