# Lake observes Joe Rush Appreciation Day Oct. 13

When Joe Rush gave notice to the Lake Tapawingo Country Club Board of Directors and the Sportsmen's Club in September 2024 that he would not be able to continue full time attendance due to medical issues, both organizations made plans to honor his many years serving the Lake Tapawingo community.

The Lake Tapawingo City Council passed a proclamation declaring Oct. 13 "Joe Rush Appreciation Day." The council also is to place Joe's name on the "Lake Tapawingo Award of Excellence" plaque that is displayed in City Hall and already lists Joe's father, Leo.

WHEREAS, Joe Rush served his country, volunteering in 1968, as a United States Naval Construction Battalion "State of United his lifesaving qualification earned at Lake Tapawingo, to have a special assignment in Seelbees training, followed by two tours in the Republic of Vietnam; and.

WHEREAS, when Joe Rush became an adult take resident in 1889, he determined to become the longest serving Director on the Lake Tapawingo Board of Directors, for the first period from 1992 to 2008 and again from 2011 to present he accomplished his goal, he recognized new needs and delivered the Lake Tapawingo News; and,

WHEREAS, he became a member of the Lake Tapawingo Sportsmen's Club in 1990 he filled Officer roles of Secretary, President and recent years as Second Vice President scheduling and working on Club activities including arranging for judges and trophiles for the Fourth of July Boat Parade, providing and pulling the trailer during the St. Patrick's Day Parade, and managing paper and can recycling; and,

WHEREAS, Joe Rush was best known and appreciated to be the "Go to Guy" to call for assistance in opening the gate to launch sidednt's boats, going so far as buying a boat trailer to help with that effort by distributing shares which filled up so he bought a second boat trailer to continue to help; and,

WHEREAS, Joe Rush also participated in the Blue Springs community as a lifetime member of the Veterans of Foreign Wars and a long-time member of the American Legion; and,

WHEREAS, health treatments now restrict Joe Rush from his full efforts, it is entirely fitting and proper to honor the many years of his willing volunteer service to our Lake residents; and,

#### **Chief Taylor resigns from Lake PD**

Police Chief Tammy Taylor has resigned from the Lake Tapawingo Police Department, which she had led for the past six years.

The department is expected to operate as usual during the transition to a new chief. Residents needing assistance, as usual, should call 911, which contacts the Jackson County Sheriff's Department, which dispatches Lake Tapawingo police. For administrative matters, the Lake Tapawingo Police number is (816) 224-6645.

Taylor was named chief in 2018 after serving 15 years with the Lake Winnebago Police Department, where she had been second in command with the rank of lieutenant.

#### Need invasive species training? Call us!

Because folks are hunkering down for winter and preparing for the holidays, a regular invasive species training session is not scheduled for November. Instead, you can get trained by appointment.

Just contact the Lake Office at office@ laketapawingomo.com or (816) 228-3721.

Training, which normally is on the third Saturday of each month, is required before residents may obtain boat registration stickers or dock permits, or use the lake "for any activity."

Lake Rules prohibit the transfer of boats and gear between Lake Tapawingo and other water bodies unless quarantined before they return to Lake Tapawingo. Violation of invasive species rules -- including using the lake without prior invasive species training -- can result in revocation of Lake privileges for up to a year, fines by the Missouri Department of Conservation or other agencies, or civil damages awarded to the Lake Tapawingo Country Club.

The state has confirmed that zebra mussels are in Jackson County's interconnected Prairie Lee Lake, Lake Jacomo and Blue Springs Lake. They are also in nearby Lake Lotawana, Longview Lake and other lakes including the Lake of the Ozarks.

Zebra mussels are spread by human activity, transporting infected boats, docks, lifts and assorted gear to previously "clean" bodies of water.

# City Council vote proclaims Joe Rush Day

The Board of Aldermen of the city of Lake Tapawingo met Oct. 3 at City Hall. Mayor Tom Rodenberg presided.

**Visitors:** Ty Francis, 3 Emerald Shore; Charles Plank, 38 Dockside; Elizabeth Braden, 45 Anchor.

Joe Rush honored: Alderman John Nicol presented a city proclamation to honor Joe Rush, 80 Beach, explaining Rush's deteriorating health has led him to not run again for the Lake Board or as vice president of the Sportsmen's Club. Nicol said he interviewed Rush to get his historical background from his many years at Lake Tapawingo.

Rush is undergoing dialysis three days a week and due to his health is not able to be as active in the community as he has been for many years. He is the longest serving Country Club Board member along with many years serving on the Sportsmen's Club.

Nicol said the Country Club Board and the Sportsmen's Club wanted to acknowledge Rush's many years of service and have a "Joe Rush Appreciation Day" on Oct. 13. Mayor Rodenberg said he would sign the proclamation and City Clerk Paul Blixrud would attest the mayor's signature.

The city also is to add Rush's name to the "Lake Tapawingo Award of Excellence"

Planning and Zoning: Alderman Steve Magel asked the City Council to review Planning and Zoning Commission recommendations for ordinance changes. He asked the council to respond to him within seven to 10 days with comments. Magel said he and City Attorney Paul Campo would then discuss drafting ordinances for a second review by the Planning and Zoning Commission before the council votes on the recommendations.

Magel said the commission also planned to meet for discussion of additional concerns, including codes enforcement of city ordinances. Magel said there were a few ways to go about codes enforcement, from hiring a part-time police officer to hiring a code

enforcement officer. Alderman Gary George asked if the city's building official could also serve as code enforcement, which is to be addressed.

Magel said in the past month, seven projects had to be stopped because no building permit was obtained.

Mayor's Christmas Tree: Mayor Rodenberg said the Mayor's Christmas Tree lighting ceremony was expected to be held at 5:30 p.m. Dec. 1, at the evergreen tree beside the City Hall mailbox.

Executive session: Alderman Traci Via moved at 6:28 p.m. to adjourn the open meeting and reconvene in closed executive session pursuant to Missouri Sunshine Law 610.021.1 (legal) and 610.021.13 (personnel records). Alderman Steve Magel seconded the motion, which passed 4-0. Following the discussion, Magel moved to adjourn the closed session and reconvene in open session. Alderman Gary George seconded the motion, which passed, 4-0. The council returned to an open meeting and adjourned at 7:24 p.m.

The remaining three council members, Steve Magel in Ward 1, Lisa Hodges in Ward 2 and Bob Seago in Ward 3, have terms that expire in April 2026.

Five seats of the 15-member Lake Tapawingo Country Club Board will be up for election in February for three-year terms, while a sixth seat is up for the remaining year of a term. Candidates must be recruited by about New Year's Day.

The Lake Board is required to select a nominating committee no later than 60 days before the Feb. 20 election, about Dec. 22, to recruit board candidates. The earlier the better, because it can be hard to recruit candidates over the Christmas holidays.

Ideally, at least seven board candidates are needed to run for the six vacancies to ensure voters have a choice -- and to give the minimum-required 50 voters a reason for showing up to vote.

Lake Rules require the nominating committee to report back its nominees at least 45 days before the Feb. 20 Property Owners Meeting and election -- about Jan. 6. Then ballots can be prepared and residents notified by letter of the candidates before the election, scheduled for 7 p.m. at the Clubhouse.

Candidates also may be nominated from the floor of the Property Owners Meeting and election Feb. 20.

Property owners who want to express their interest in serving on the Lake Board may contact the Lake Office, (816) 228-3721, to find a Nominating Committee member.

Normally only five seats, representing a third of the board, are up for election each year. The five regular seats up for three-year terms include those held by Clayton Holland, Scott Johnson, Wes Knox, Joe Rush and Susan Stiles. Rush has already said he will not be seeking re-election.

Also up for election is the remaining one year of the term of Kim McReynolds, who said she is resigning and moving from the Lake by the end of the year. Under usual procedures of the election, the top five vote-getters would win the five three-year terms, with the sixth vote-getter receiving the one-year term.

Continuing on the Lake Board are Board Members Darren Davis, Andy Gibler, Sarah Jordan, T.J. McGinnis, John Nicol, Scott Patton, Brian Smith, Mike Stiles and Brian Zoller.

## Heads up: Mayor's Tree, election coming, senior tax relief

Greetings, All. I hope your October was very pleasant. You just can't beat the fall weather and colors. We have some very beautiful trees in our lake community.

A couple of December heads-ups. My wife Kathey and others have been working toward a first Mayor's Christmas tree lighting on Dec. 1. If you are considering a new roof/replacing your current roof, or even a deck repair or replacement, you should check on the requirement for a building permit. It is very possible that your roof replacement could be subject to obtaining a building permit.

Also, remind any contractor that before they begin work, they need to obtain a city license. Just have them go to City Hall and check with the city clerk who can issue the license.

#### Seniors, contact Jackson County for property tax relief


For the seniors among us, a reminder that you must apply before the end of the year to benefit from the Jackson County Senior Property Tax Relief program. In response to new Missouri law, Jackson County has established an application process to bring senior citizens much-needed tax relief.

The program now allows those taxpayers who are 62 years of age or older to receive a credit that essentially freezes their property taxes on their primary residence. To qualify, a taxpayer needs to be 62 years of age or older, be the property owner, or have a legal or equitable interest in the home, be liable for the payment of real property taxes on the home and occupy the property as primary residence.

The deadline for the initial application is Dec. 31. Please go to the Jackson County website, jacksongov.org/Home, for complete details. Don't miss out on this great tax relief for seniors.

The City's annual audit was recently completed. The Board of Aldermen will be getting a full report in a future meeting. This is a very important part of keeping your City financially sound.

# Rules on warning flags, fishing win final approval

The Lake Tapawingo Country Club Board of Directors met Oct. 21 at the Clubhouse. President Darren Davis presided.

**Visitors:** Ty Francis, 3 Emerald Shore; Scott Osborne, 142 Dockside; Charles Plank, 38 Dockside; John Braden, 45 Anchor.

**November meeting:** President Davis said there would be no Nov. 4 board meeting due to an expected lack of a quorum. The next board meeting would be at 7 p.m. Nov. 18 at the Clubhouse.

**Board resignation:** Board Member Kim McReynolds said she would be moving from the Lake by the end of the year and would be resigning from the board and her position as secretary. She urged the board to find a successor to be secretary so she could assist in the transition.

**Lake Management: Drought warning.** President Davis asked Board Member Clayton Holland for his opinion on continuing the red flag warning of a no-wake lake and a ban on watering with lake water. Holland said the flags need to stay up as the level of the lake continues to go down due to inadequate rain. Davis agreed.

Bylaws, Rules and Regulations: Communications rules. Secretary Kim McReynolds presented third reading of three rules related to communications and the intent of the red flags posted on community bulletin boards. After the RENTAL RULES section, a new section named, "COMMUNICATIONS" would be added with the following three new rules that address Country Club communications methods.

On third reading, the new rules read as follows:

#### COMMUNICATIONS

1. Any amendments to the Rules and Regulations will be posted on the community bulletin boards located at each of

the three entrance gates and on the official Lake Tapawingo Country Club website (www.laketapawingomo.com) within five (5) business days. Additionally, notifications of these amendments may be sent via phone, text message, or email.

- 2. The Lake Tapawingo Country Club will post a red flag on each of the three (3) community bulletin boards located near the three (3) entrance gates whenever there is an important update to share with the community. This may include safety or precautionary information, amendments to the Rules & Regulations, water quality notifications, or any other information the Lake Tapawingo Country Club considers urgent and important. The reason for the red flag will be included beneath the flag and residents are advised to review the important information posted.
- 3. The Lake Tapawingo Country Club may temporarily modify the rules and regulations concerning lake usage due to specific environmental conditions or to protect life and property. These modifications may include changes to speed limits, directional rules, access, or usage. Notifications will

# Lake Board approves waiver for metal roof

be posted on the community bulletin boards at the entrance gates beneath the red flags, on the official website of the Lake Tapawingo Country Club (www.laketapawingomo.com), and/or communicated via phone, text message, or email.

The board approved, 11-0, a motion by McReynolds to adopt the three rules on third reading.

**Fishing rules.** McReynolds then presented, for third reading, amendments to FISHING RULES as follows (with deletions in stricken type):

## FISHING RULES B. GENERAL RULES AND GUIDELINES

- 4. Throw lines, trotlines, or setlines are prohibited. Not more than two (2) poles or lines with not more than two (2) hooks per line are permitted to each person. Each linemust be attended at all times. (3 points) Allowed Sport Fishing Method: Pole and Line (also known as rod and reel). Ice fishing tackle or tip-ups are considered a pole and line method.
- 5. **Quantity:** Not more than two (2) poles or two (2) lines are permitted to each person. No more than two (2) hooks per pole or line are permitted to each person. A treble hook or a lure with multiple hooks is considered a single hook. (3 points)
- 6. **Attendance:** Each pole and line must be attended at all times. (3 points)
- 7. **Restrictions:** All other methods not explicitly specified as allowed methods in section 4 above are strictly prohibited. This includes, but is not limited to, throwlines, trotlines, setlines, throw nets, jug lines. (3 points)
- 8. **Non-Sport Fishing Methods are Prohibited:** Use of explosives, poison, chemical, or electrical equipment to capture, kill, or stupefy fish is strictly prohibited. (9-16 points)

Because of the addition of the new rules, the following existing rules would be renumbered with no other changes to those rules:

# B. GENERAL RULES AND GUIDELINES (RENUMBERING):

ITEM 5 becomes ITEM 9.

ITEM 6 becomes ITEM 10.

ITEM 7 becomes ITEM 11.

ITEM 8 becomes ITEM 12.

The spelling of "stupefy" was corrected in Item 8. The board then approved, 10-0 with 1 abstention, a motion by McReynolds to adopt the amendments on the third reading.

#### Waiver of restriction on metal building coverings.

President Davis reported he had submitted by e-mail a request to board members from resident Elizabeth Goodbrake to replace a portion of her current corrugated plastic roofing with metal roofing at 69 Anchor. He said he's known three other metal roofs in the past three years to be approved by the board. He said the request was approved by e-mail, 9-0.

Although the city regulates most building construction, the board had to approve an exception to the Lake Tapawingo's Original Corporation Warranty Deed, which prohibits any residence from being covered wholly or partially by metal.

Davis asked when the covenant could be amended to avoid need for such requests in the future. Secretary Kim McReynolds said the Original Corporation Warranty Deed Covenant could be amended by a vote of property owners every 20 years, with the next opportunity for amendment to be in 2026. Davis suggested starting to make a list of covenant provisions that might need amending in 2026 to become up to date.

**Treasurer's Report:** Treasurer Scott Johnson said 2024 revenue collected so far is above budget predictions: including property transfer fee revenue that was budgeted at \$20,000 and exceeding that to total \$27,000; Clubhouse rent budgeted

#### MARKET NEWS

Mortgage rates rose last week, with the selloff due to the market starting to price in election outcomes of November. We have seen a steep increase in rates the last few weeks, it is simply down to the economy being stronger than the market expected, along with the market starting to price in specific election outcomes. This week, we get core-PCE (Fed's favorite inflation measure), along with Nonfarm payrolls and JOLTS Job Openings. Those pieces of data could move bonds. The hope is that we get some data this week that sends mortgage rates lower.

# Lake Board revenues exceed budget projections

at \$8,000 and exceeding that to \$12,700; and interest income budgeted at \$12,000 and earning just over \$26,000.

Johnson said, including checking accounts, savings accounts and investments, the Country Club's estimated assets total about \$978,000 with no debt.

Johnson presented a choice of investment rates when considering investing once again in a Treasury Bill. He said the latest investment has reached maturity and concluded a total of roughly \$619,000 with the added interest. He moved to reinvest those funds with additional funds from a Commerce Bank checking account owned by the Country Club making a total of \$640,000 at 4.31 percent reaching a maturity date on Jan. 9, 2025.

He said Treasury Bills have been trending down in interest rates over the last year and he wants to take advantage of the higher rates before the general election. The board approved, 11-0.

**Budget Committee.** Johnson said the Budget Committee meeting was scheduled for 7 p.m. Oct. 29 at the Clubhouse. He said he would meet with various board members to discuss amounts to be requested for their departments. President Davis advised board members to review the proposed budget from the committee and if they are not able to attend the committee meeting to contact himself or another board member to raise any concerns or questions.

Board Member Brian Smith asked whether funds could be budgeted for repair of rot in the Liberty Landing dock. He said Williams Lakefront Construction had provided bids for installation of concrete and galvanized framing or replacing the entire dock. Johnson said the board and Budget Committee could discuss the matter.

**Real Estate:** Board Member Scott Johnson asked if the board could change the rule that states if the Country Club sells a property, it is an unbuildable lot. Johnson said if that rule were to be changed, it could open the potential for the Country Club to sell property for more revenue.

Board Member Scott Patton said if the Country Club would start selling remaining lots the community would lose a lot of the remaining green space around the lake. He expressed concern that if all the green space is sold, then Lake Tapawingo would turn into what feels like a swimming pool encased in concrete.

Board Member John Nicol said dock space already is limited. He said the more homes that are added to the Lake, the more likely some people would be unable to own a dock. President Davis said he thinks only "convenient" dock space would be hindered. He said people want easy access to their docks without walking a great distance to get there.

John Braden said in the most recent previous discussion of possible property sales, former President Jayme Dean had said the Country Club would have a heavy capital gains tax if property were sold without reinvestment in another property.

Johnson said with a community vote, the board could package the empty lots and sell them to a developer for a good price. Nicol said Country Club rules are designed to prohibit sales to developers by prohibiting the sale, rental or occupation of a new house by anyone but the owner of record for at least one year after a certificate of occupancy is issued.

Davis said he knew of three people interested in buying Country Club properties that are adjacent to their properties.

Board Member Joe Rush concluded the Lake needs the green space, there are no additional dock spaces and the Country Club does not need the money that badly.

Grounds Management: AT&T Fiber boring. President Davis said AT&T Fiber hired a subcontractor that bored under Dockside Drive and brought fiber-optic cable under Dockside Drive. He said they were able to run the cable down Dockside Drive all the way to 117 Dockside Drive. However, Davis said the subcontractor hit the main sewer line twice during the boring. He said one break was in the same spot as the last time AT&T tried to lay fiber in the area.

Davis said he halted the project after the subcontractor asked to cut a portion of the road to lay the cable. He said he denied it because there were no plans presented to fix the road afterward and they had already left multiple holes from boring. Board Member Clayton Holland said there is a Lake Tapawingo city ordinance that specifies how road cuts must be repaired.

Board Member Kim McReynolds asked if AT&T planned to install fiber cable on poles to the houses that couldn't be reached by buried line. Davis said some of the houses would be served by aerial cable, but the majority would be buried line. He said everything can't be hung due to the cable weight, but the only thing left to do is connect everything along Woods Chapel Road.

Board Member Brian Smith asked if permission was given to the subcontractors to dump excess dirt on Country Club property behind the dam. Davis said they were not and that he



# City seeks more responses to lead pipe inventory

City Clerk Paul Blixrud sent notices in October utility bills to those residents who reported having lead or galvanized steel water pipes or who have not responded to a request to report the composition of their water lines.

All Lake residents received an initial notice in February that the city and state would like their help in surveying for hazardous lead in household pipes. That letter from the city said the Missouri Department of Natural Resources required each water system to submit an inventory of lead water lines by Oct. 16, 2024.

The latest notice is directed at residents who are: Confirmed: Lead Service Line; Confirmed: Galvanized Requiring Replacement; or Unknown: Possibly Lead.

The earlier notice did not make it clear the state seeks replacement of galvanized steel pipe in addition to lead pipes. A DNR

publication explains "If there are lead connectors or lead service lines upstream of galvanized service lines, lead leached from them can flow downstream and collect on the galvanized coating. Galvanized steel pipes can periodically release this lead, even after the lead piping is removed."

So far there has been no penalty for failure to comply with the pipe survey;

the household would simply be marked unknown. The latest notice talks about the health effects of lead and says City Hall can be contacted for information on financial options for pipe replacement. The city is not responsible for replacing lines that are on the resident's side of the water meter.

Residents were asked to check their own pipes and report the composition of their service lines, even if they are not lead. The flier from the city demonstrated how to perform scratch tests on pipes to determine their composition. Copies of the flier may be obtained from City Hall.

In 2014, federal law set a lower level of lead content in pipes, fittings and fixtures of .25 percent. Missouri banned lead in plumbing in 1989.

would consult city Alderman Bob Seago. Holland said he would have Maintenance Coordinator Matt Kempf change the lock code to the dam gate so it no longer would be accessible.

Mailbox replacement. Board Member Scott Patton said mailboxes on Anchor, Beach, and Clipper were found to be burglarized on the morning of Oct. 21. He said mail was stolen from possibly 50 boxes.

He suggested asking property owners if they would be interested in cluster mailboxes like those in some new housing additions. He said some people like their mailboxes in their yard, but some would like them more secure. Board Member T.J. McGinnis said there were several community meetings coming up, and it might be a good idea to have a conversation with the community.

President Davis said usually the community would have to purchase the boxes and then coordinate with the Post Office about keys. John Braden said installation of boxes might be complicated because there are no public easements along Lake roads. Davis said sometimes cluster boxes are placed at a city hall with lighting and cover from the weather.

**Docks and Waterfront: 35-B.** President Davis reported he presented by e-mail an application from Tom and Kathey

Rodenberg to add an upper level to the existing dock at 35-B. He said the application was approved, 8-0, by e-mail vote. John Braden asked if the existing dock had a boat slip in the middle. Board Member Brian Smith said no.

**22-A.** President Davis said the seawall has been repaired at the end of the pathway beside 22 Anchor. He said contractor Chad Eickleberry completed the work and removed all excess materials from the work area.

10-C. Board Member Kim McReynolds noted a boatlift approved for the 10-C dock at the Aug. 21, 2023, meeting had been installed on the wrong side of the dock and the house is being offered for sale without the issue being resolved. President Davis said the matter should be discussed in closed executive session.

Scott Osborne, 142 Dockside, said board action Feb. 20, 2024, required him to pay to move a neighbor's dock so he would have room for a boatlift but he has measured other docks that are not compliant with dock spacing rules. Board Member Brian Smith said the board has not approved docks that are closer than 15 feet to neighboring docks.

Maintenance: Tree removal, trimming. Board Member Brian Smith presented seven proposals from Monster Tree Service for tree care around the lake: 244-D, total removal of diseased tree, optional stump grinding and grinding removal, \$1,989; 88-A, total tree removal, \$1,755; 68-A, total tree removal, \$2,223; 32-E, Structural pruning, \$1,452; 28-E, total tree removal, \$936; 11-C, rejuvenation pruning, \$936; 10-E, total tree removal, \$702. The board passed, 11-0, Smith's motion to approve all bids.

Scott Osborne, 142 Dockside, said a pathway near his home, between 66-D and 68-D, contains a stump and a rotten tree that are hazardous. Smith said they would be put on the list for examination. Board Member Clayton Holland said the Jackson County Parcel Viewer had indicated the tree is not in the pathway but he would check again.

Bulletin boards. Board Member Clayton Holland said the plywood surface had been replaced on the bulletin board by the U.S. 40 gate. Board Member John Nicol said the new wood should be stained to match the rest of the board. Board Member Kim McReynolds said a space on the board should be reserved for Country Club notifications.

Woods Chapel inlet: President Davis said there are no updates on the Woods Chapel Inlet Project. He said Affinis engineering has not responded to a request for a plan to mitigate damaging inflows into C Cove during heavy rains.

# Lake voters go to the polls Nov. 5 to decide races, questions

In addition to a long-awaited presidential election, Lake Tapawingo's general election ballot Nov 5 includes races for Missouri governor, lieutenant governor, U.S. Senate, secretary of state, state treasurer and attorney general. Polls are open from 6 a.m. to 7 p.m. Tuesday, Nov. 5 at the Clubhouse.

**President:** At the top of the ticket are presidential candidates and their running mates. (Note, sample ballots list party order: Republican, Democrat, Libertarian, Better and Green parties.) They are Republican former President Donald J. Trump, Democratic Vice President Kamala Harris, Libertarian Chase Oliver, and Green Jill Stein.

U.S Senate: Republican Sen. Josh Hawley, Democrat Lucas Kunce, Libertarian W.C. Young, Better Party Jared Young, Green Nathan Kline.

U.S. House, 5th District: Republican Sean E. Smith, Democratic U.S. Rep. Emanuel Cleaver II, Libertarian William Truman "Bill" Wayne, Green Michael Day.



**Governor:** Republican Lt. Gov. Mike Kehoe, Democratic Missouri House Minority Leader Crystal Quade, Libertarian Bill Slantz, Green Paul Lehmann.

**Lieutenant Governor:** Republican Dave Wasinger, Democrat Missouri Rep. Richard Brown, Libertarian Ken Iverson, Green Danielle "Dani" Elliott.

**Secretary of State:** Republican Missouri Sen. Denny Hoskins, Democrat Missouri Rep. Barbara Phifer, Libertarian Carl Herman Freese, Green Jerome Bauer.

**State Treasurer:** Republican State Treasurer Vivek Malek, Democrat Mark Osmack, Libertarian John A. Hartwig Jr., Green Reagan Haase.

**Attorney General:** Republican Attorney General Andrew Bailey, Democrat Elad Jonathan Gross, Libertarian Ryan L. Munro.

**Missouri House, 33rd District:** Republican Carolyn S. Caton of Blue Springs is unopposed.

**Jackson County Prosecutor:** Republican Tracy Chappel, Democrat Melesa Johnson.

Democrat Jackson County Sheriff Darryl Forte is unopposed for re-election. In addition, 15 Missouri judges are on the ballot for yes-no retention votes.

#### Five amendments, a proposition and a question offered

The first of five constitutional amendments on the ballot, Constitutional Amendment No. 2, which was placed on the ballot by initiative petition, would amend the Missouri Constitution to legalize sports betting including: online, at gambling "boats," professional sports betting districts, and mobile licenses to sports betting operators. It would allow license fees to the Missouri Gaming Commission and a 10 percent wagering tax on revenues to be appropriated for education after expenses incurred by the commission and required funding of the Compulsive Gambling Prevention Fund. State government entities estimate passage would require one-time costs of \$660,000 and annual costs of at least \$5.2 million. Because the proposal allows for deduction against sports gaming revenues, they estimate unknown tax revenue ranging from \$0 to \$28.9 million annually.

Constitutional Amendment No. 3, which was placed on the ballot by initiative petition, would amend the Missouri Constitution to remove Missouri's ban on abortion. It would "establish a right to make decisions about reproductive health care, including abortion and contraceptives, with any governmental interference of that right presumed invalid." It would not allow the government to discriminate in programs, funding or other activity against those providing or obtaining reproductive health care. It would "allow abortion to be restricted or banned after Fetal Viability except to protect the life or health of the woman."

Constitutional Amendment No. 5, which was placed on the ballot by initiative petition, would amend the Missouri Constitution to allow the Missouri Gaming Commission to issue one additional "gambling boat" license to operate on the Osage River between the Missouri River and Bagnell Dam, which forms the Lake of the Ozarks. It would require the prescribed location to "include artificial spaces that contain water and are within 500 feet of the 100-year base flood elevation as established by the Federal Emergency Management Agency." It would require all state revenues from issuance of the gambling license to be appropriated to early childhood literacy programs. State government entities estimate one-time costs of \$763,000 and ongoing costs of \$2.2 million annually. They estimate initial fee revenue of \$271,000, ongoing admission and other fee revenue of \$2.1 million annually and annual gaming tax revenue of \$14.3 million.

Constitutional Amendment No. 6, which was placed on the ballot by the Legislature, would amend the Missouri Constitution to allow costs and fees to be levied to support salaries and benefits for current and former sheriffs, prosecuting attorneys and circuit attorneys.

# Happy 100th birthday, U.S. 40!



Before the time of Interstate 70, it was U.S. 40 highway that carried the great stream of interstate traffic right past Gate 1 of Lake Tapawingo. Before 40 received its U.S. highway designation -- and before Lake Tapawingo -- it was a state road, Sni-a-Bar Road, whose pavement was completed 100 years ago from Kansas City to the eastern boundary of Jackson County.

The Days Gone By column of the *Examiner* (examiner.net) recently carried a report from the week of Sept. 22-27, 1924, in the *Independence Examiner*. It announced the opening celebration, set for Oct. 4, 1924, of Sni-a-Bar Road as a state highway.

"At that time this great driveway of concrete eighteen feet wide will have been completed from the eastern limits at Kansas City to the eastern limits of Jackson County," the *Examiner* recorded.

Celebrants held a picnic with bands and speeches at Sni-a-Bar Farm, which had been founded by *Kansas City Star* publisher William Rockhill Nelson, then a quarter-mile south of Grain Valley. Nelson, who had died in 1915, had hired

an engineer to find a route with the best grades and fewest curves for the cross-county road, some of which began as an old oxen track. Originally dubbed Nelson's Road, it ran to his farm, which his will turned into a cattle breeding demonstration farm with proceeds to

benefit Kansas City.

The most grades and curves on the predominantly east-west route are on the stretch that eventually would pass the U.S. 40 gate of Lake Tapawingo, whose construction was not begun until two years later in 1926.

#### Proposition would increase minimum wage

**Constitutional Amendment** No. 7, which was placed on the ballot by the Legislature, would amend the Missouri Constitution to make it consistent with state law that allows only U.S. citizens to vote. Additionally, it would prohibit ranked voting for more than one candidate for a particular office and require the plurality vote winner of a political party primary to be the single candidate at a general election. The provision would not apply to any nonpartisan municipal election in a city with an effective ordinance at which more than one candidate advances to a subsequent election.

**Proposition A**, which was placed on the ballot by initiative petition, would amend Missouri law to increase the minimum wage on Jan. 1, 2025, to \$13.75 per hour and increase it another \$1.25 per hour by January 2026 when the minimum wage would be \$15 per hour. Thereafter, it would adjust the minimum wage based on changes in the Consumer Price Index each

January beginning in 2027. It also would require all employers to provide one hour of paid sick leave for every 30 hours worked. It would exempt governmental entities, political subdivisions, school districts and educational institutions. State governmental entities estimate one-time costs of \$0 to \$53,000 and ongoing costs ranging from \$0 to at least \$256,000 per year by 2027.

Question No. 1, which was placed on the ballot by the Jackson County Legislature, would authorize Jackson County to levy a property tax of 5 cents per \$100 assessed valuation to provide services to persons 60 years of age or older. The proceeds would be deposited in a Senior Citizens Services Fund administered by a seven-member board of directors appointed by the county legislature for programs to improve health, nutrition and quality of life of elderly people in the county. It was reported funds would be used for grants to established community groups such as Meals on Wheels and for transportation assistance for seniors.

# Council meets with lawyer in special closed session

The Lake Tapawingo City Council convened a special closed meeting Oct. 16 at which it met with the city's newly hired municipal defense lawyer.

Alderman Steve Magel moved at 6:31 p.m. to convene in closed executive session pursuant to Missouri Sunshine Law 610.021.1 (legal) and 610.021.13 (personnel records). Alderman Gary George seconded the motion, which passed 5-0.

Attorney Steve Coronado entered City Hall at 6:35 p.m. and joined the meeting. Coronado was hired Aug. 13 in another closed meeting called to hire a lawyer specializing in "defense of governmental entities including cities and counties."

After discussion, Alderman Bob Seago moved to exit the closed session. Magel seconded the motion, which passed 5-0.


